Critical Illness Benefit	\$15.00 maximum per day for semi-private or private accommodation for hospital services including rental of phone, TV, etc. and employment of a nurse requested by attending physician to a maximum of \$5,600.00 when listed disease diagnosed
Dentures and Artificial Teeth Benefit	\$250.00 maximum for repair or replacement of dentures or artificial teeth when required due to student's injury
Dismemberment and Specific Loss Indemnity	Ranging from \$750.00 to \$50,000.00
